

Ibec publishes Pay and HR Trends Report at Leadership Summit

Ibec's HR Update Report 2023 was launched recently at the annual HR Leadership Summit on 25 October. The survey captures key pay and HR trends in Irish workplaces. The findings show that eight out of ten businesses are planning to increase pay in 2024, with an average increase of 3.8%. Meanwhile, 45% of respondents are planning to increase their headcount next year. The findings also shed new light on the use of AI in the workplace.

Minister confirms that right of employees to seek paid Domestic Violence Leave will apply from 27 November

Speaking at the Green party annual convention in Cork city earlier this month, Minister for Children, Roderick O'Gorman is reported to have confirmed that the right of employees to seek paid Domestic Violence Leave will apply from 27 November of this year. The Minister reaffirmed this commencement date during a Dáil debate on the 24 October. This means that at the end of next month, Ireland will become one of the first countries in the EU to introduce this measure.

On 23 October, European social partners held a final round of negotiations to seek agreement on a framework agreement on telework and a right to disconnect which, if accepted by the European social partners, would be implemented by means of European Directive, if accepted by the European Council. The outcome of 23 October was a final text, agreed between the social partners, which member states will have two weeks to accept or reject.

Gender Pay Gap in Ireland stood at 9.6% in 2022 - CSO

According to the findings of the Central Statistics Office's Structure of Earnings Survey 2022, Ireland's Gender Pay Gap stood at 9.6% last year with the average hourly wage for men coming in at €27.73 and the average hourly wage for women at €25.06. In economic sectors, the highest GPG was in the financial, insurance and real estate sector with the lowest GPG recorded in the education sector.



Supreme Court rules pizza company delivery drivers should be treated as employees not contractors

The Supreme Court published its long-awaited decision in *The Revenue Commissioners v Karshan (Midlands) Ltd t/a Dominos Pizza* on 20 October 2023. This decision is of huge importance to employers and sets out a new method for establishing the existence of employment relationships, although the underlying historical tests remain valid.

Employer ordered to pay over €50k in compensation to office worker for failure to provide suitable workstation

The Workplace Relations Commission in recent weeks awarded over two years' salary to a worker, a sum of €50,255, for what the WRC Adjudicator described as an inexcusable delay on the part of her employer to not to accommodate the woman's back condition and to act on the low-cost recommendations by medical experts which would have enabled her to gradually return to full time hours.



Minister Richmond approves Labour Court Review of the JLCS

The Labour Court Review recommends maintenance of the nine Joint Labour Committees (JLCs) already in existence: Agricultural Workers; Catering; Contract Cleaning; Hairdressing; Retail; Grocery and Allied Trades; Security; Early Years Learning; and English Language Schools.

Contract Cleaning Pay Increase proposed

A new contract cleaning rate has been proposed by the Contract Cleaning Joint Labour Committee. The JLC has proposed a €1.40 increase in the single hourly minimum rate for an estimated 30,000 workers in the sector. The proposal comes after confirmation in Budget 2024 that the National Minimum Wage will increase to €12.70 from January 1, 2024 thereby rendering the pay terms of the current contract cleaning ERO out of date.
